A RESOLUTION OF THE LODI CITY COUNCIL APPROVING SPECIFICATIONS FOR THE HUTCHINS SQUARE POOL REPAIR, AUTHORIZING INTERIM CITY MANAGER TO AWARD CONTRACT TO LOWEST RESPONSIVE BIDDER AND EXECUTE CHANGE ORDERS, ACCEPTING DONATIONS FROM HUTCHINS STREET SQUARE FOUNDATION, AND APPROPRIATING FUNDS

WHEREAS, this project will provide specialized structural concrete remediation at the Hutchins Street Square Pool (Pool), utilizing pressure epoxy injection to restore the monolithic integrity of the concrete shell and mitigate hydrostatic leakage; and

WHEREAS, with the intention of completing this project as quickly as possible, Staff utilized the City's Uniform Public Construction Cost Accounting Act portion of the adopted purchasing policy to prepare specifications and advertise bids. The specifications are on file in the Public Works Department. The planned bid opening is June 10, 2026. The project estimate is \$35,000; and

WHEREAS, Hutchins Street Square Foundation (HSSF) has offered a restricted donation of \$40,000 for the project. If the donation is accepted by Council, any monies remaining after the improvements are accepted shall be returned to the HSSF; and

WHEREAS, Staff recommends that the City Council authorize the Interim City Manager to award contract to lowest responsive bidder and execute change orders (\$40,000 Combined), accept donations from Hutchins Street Square Foundation (\$40,000), and appropriate funds (\$40,000) to Parks Capital (43299000.77020); and

NOW, THEREFORE, BE IT RESOLVED that the Lodi City Council does hereby authorize the Interim City Manager to award contract to lowest responsive bidder and execute change orders (\$40,000 Combined), accept donations from Hutchins Street Square Foundation (\$40,000), and appropriate funds (\$40,000) to Parks Capital (43299000.77020); and

BE IT FURTHER RESOLVED that the Lodi City Council does hereby authorize the Interim City Manager to return any remaining funds from the donation that are not utilized on the project; and

BE IT FURTHER RESOLVED, pursuant to Section 6.3q of the City Council Protocol Manual (adopted 11/6/19, Resolution No. 2019-223), the City Attorney is hereby authorized to make minor revisions to the above-referenced document(s) that do not alter the compensation or term, and to make clerical corrections as necessary.
