A RESOLUTION OF THE LODI CITY COUNCIL AUTHORIZING THE INTERIM CITY MANAGER OR DESIGNEE TO EXECUTE A FIVE (5)-YEAR AGREEMENT, WITH AN OPTION TO EXTEND FOR AN ADDITIONAL FIVE (5)-YEAR TERM, WITH OUTREACH MINISTRIES INTERNATIONAL, INC. FOR OPERATION OF THE LODI ACCESS CENTER AND EMERGENCY SHELTER

WHEREAS, the City of Lodi issued a Request for Proposals (RFP) for the operation of the permanent Lodi Access Center and Emergency Shelter, a 24/7 low-barrier facility intended to provide immediate access to shelter, navigation services, and connections to housing and supportive resources; and

WHEREAS, following a competitive evaluation process, the City Council previously selected Outreach Ministries International, Inc. (OMI) based on the ranking and recommendation of the Evaluation Committee and authorized staff to negotiate an agreement for operation of the Lodi Access Center and Emergency Shelter; and

WHEREAS, City staff has completed negotiations with Outreach Ministries International, Inc., including budget, operational expectations, performance measures, staffing, reporting requirements, fiscal considerations, and coordination with San Joaquin County Behavioral Health Services and San Joaquin Health related to CalAIM reimbursement opportunities and service delivery responsibilities; and

WHEREAS, the proposed agreement provides for a five (5)-year term with an option to extend for one (1) additional five (5)-year term, contingent upon the availability of funding, with a first-year City contribution of \$1,620,000 supported through available grant resources and eligible funding sources; and

WHEREAS, the City Council has reviewed the proposed agreement and finds it in the best interest of the City to authorize execution of the agreement for operation of the Lodi Access Center and Emergency Shelter.

NOW, THEREFORE, BE IT RESOLVED that the Lodi City Council does hereby authorize the Interim City Manager or designee to execute a five (5)-year agreement, with an option to extend for one (1) additional five (5)-year term, and any non-substantive administrative documents necessary to implement the agreement, with Outreach Ministries International, Inc. for operation of the Lodi Access Center and Emergency Shelter, in a form approved by the City Attorney; and

BE IT FURTHER RESOLVED, pursuant to Section 6.3q of the City Council Protocol Manual (adopted November 6, 2019, Resolution No. 2019-223), the City Attorney is hereby authorized to make minor revisions to the above-referenced document(s) that do not alter the compensation or term, and to make clerical corrections as necessary.
