A RESOLUTION OF THE LODI CITY COUNCIL AUTHORIZING THE INTERIM CITY MANAGER OR DESIGNEE TO EXECUTE AN AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT WITH RRM DESIGN GROUP, EXPANDING THE SCOPE OF WORK TO INCLUDE DOWNTOWN SPECIFIC PLAN IMPLEMENTATION SUPPORT SERVICES AND EXTENDING THE TERM OF THE AGREEMENT THROUGH JUNE 30, 2027

WHEREAS, the City entered into an Agreement for Professional Services with RRM Design Group effective August 22, 2024, for the Downtown Specific Plan; and

WHEREAS, the Downtown Specific Plan is a City Council Strategic Goal intended to support downtown revitalization, economic development, historic preservation, placemaking, and infrastructure planning; and

WHEREAS, the project is progressing slightly under budget, resulting in available unexpended funds within the existing agreement; and

WHEREAS, RRM Design Group has requested a one-year extension of the agreement term to provide implementation-related support services associated with the Downtown Specific Plan, including historic preservation services, quiet zone framework development, Main Street corridor design coordination, UPRR parcel research, Downtown Mixed-Use design guideline refinement, project management, and related follow-up implementation items; and

WHEREAS, the amendment would extend the agreement term through June 30, 2027 with no increase to the approved contract amount; and

WHEREAS, staff recommends approval of the amendment to support continued implementation of the Downtown Specific Plan and related revitalization efforts.

NOW, THEREFORE, BE IT RESOLVED that the Lodi City Council does hereby authorize the Interim City Manager or designee to execute Amendment No. 1 to the Professional Services Agreement with RRM Design Group for Downtown Specific Plan Implementation Support Services and extend the term of the agreement through June 30, 2027; and

BE IT FURTHER RESOLVED, pursuant to Section 6.3q of the City Council Protocol Manual (adopted 11/6/19, Resolution No. 2019-223), the City Attorney is hereby authorized to make minor revisions to the above-referenced document(s) that do not alter the compensation or term, and to make clerical corrections as necessary.
