A RESOLUTION OF THE LODI CITY COUNCIL AUTHORIZING THE CITY MANAGER TO EXECUTE AMENDMENT NO.2 TO PROFESSIONAL SERVICES AGREEMENT WITH UNIFIRST - FIRST AID CORPORATION FOR CITYWIDE FIRST AID AND SAFETY SERVICES

WHEREAS, currently first aid stations in City facilities are managed by each individual department; and

WHEREAS, Risk Management would like to consolidate the oversight of the first aid supplies and stations to one contract to ensure Cal/OSHA compliance and to take advantage of more favorable bulk pricing; and

WHEREAS, on July 28, 2022, the Electrical Utility Department executed a Professional Services Agreement with Unifirst – First Aid Corporation (then called Certified First Aid) in the amount of \$16,500 with an expiration date of June 30, 2027; and

WHEREAS, on June 27, 2024, the Electrical Utility Department approved Amendment No. 1, which increased funds by \$23,500 for a total not-to-exceed amount of \$40,000; and

WHEREAS, Amendment No.2, will increase the contract by \$45,000 for a total not-to-exceed amount of \$85,000 to expand the scope of the contract to all City departments; and

WHEREAS, staff recommends authorizing the City Manager to execute Amendment No. 2 to Professional Services Agreement with Unifirst – First Aid Corporation for Citywide First Aid and Safety Services for \$45,000 for a total not-to-exceed amount of \$85,000.

NOW, THEREFORE, BE IT RESOLVED that the Lodi City Council does hereby authorize the City Manager to execute Amendment No. 2 to Professional Services Agreement with Unifirst – First Aid Corporation for Citywide First Aid and Safety Services for \$45,000 for a total not-to-exceed amount of \$85,000; and

BE IT FURTHER RESOLVED, pursuant to Section 6.3q of the City Council Protocol Manual (adopted 11/6/19, Resolution No. 2019-223), the City Attorney is hereby authorized to make minor revisions to the above-referenced document(s) that do not alter the compensation or term, and to make clerical corrections as necessary.
