
RECOMMENDED ACTION: That the City Manager authorize the purchase of one 2025 Chevrolet Traverse from Sanborn Chevrolet of Lodi, CA, in the amount of \$54,149.70, an additional \$4,997.95 for the purchase of a Harris Mobile Radio from Dailey-Wells Communications, Inc., and an additional \$7,615.16 for the installation of emergency and electronic equipment through Lehr Auto, CA, for the total price of **\$66,762.81**.

BACKGROUND INFORMATION: This vehicle purchase and disposition is taking the place of car 05-091, a 2015 Hyundai Sonata. This vehicle was budgeted for replacement and approved in the 2025/2026 fiscal year budget.

The 2015 Hyundai Sonata (05-91) is **10 years old** and has **102,479** miles as of 8/14/2025. The guidelines for replacement of this class of vehicle are 3-8 years / 80,000 miles. The total repair and maintenance costs on this vehicle to date are **\$17,547.24**, and it has an estimated value of \$2,000-\$4,000. After considering these factors, it is recommended that a replacement be purchased now.
