A RESOLUTION OF THE LODI CITY COUNCIL ACCEPTING AND APPROPRIATING THE HOMELESS HOUSING, ASSISTANCE, AND PREVENTION (HHAP) ROUND 5 GRANT, IN THE AMOUNT OF \$426,627.44, AND AUTHORIZING THE INTERIM CITY MANAGER OR DESIGNEE TO EXECUTE HHAP ROUND 5 SUBRECIPIENT AGREEMENTS IN A FORM ACCEPTABLE TO THE CITY ATTORNEY

WHEREAS, the State of California Homeless Coordinating and Financing Council (HCFC), in coordination with the Business, Consumer Services and Housing Agency (BCSH), has made available Homeless Housing, Assistance, and Prevention (HHAP) Round 5 funding pursuant to Assembly Bill 101 (Chapter 159, Statutes of 2019), to support regional coordination and evidence-based strategies to address homelessness; and

WHEREAS, the San Joaquin Continuum of Care (SJCoC) and San Joaquin County jointly administer HHAP funds and released a coordinated Notice of Funding Availability (NOFA) for HHAP Round 5; and

WHEREAS, the City of Lodi submitted an application for HHAP Round 5 funding to support the continued operation of the Lodi Access Center and Emergency Shelter, street outreach, services coordination, and prevention and shelter diversion activities; and

WHEREAS, the City of Lodi has been recommended for an award in the amount of \$426,627.44.

NOW, THEREFORE, BE IT RESOLVED that the Lodi City Council does hereby accept and appropriate the HHAP Round 5 Grant, in the amount of \$426,627.44, to revenue account 35500000.56005 and expense account 35599000.77020 utilizing project strings (new): ARPA-22001.Contracts.HHAP5.Operations (\$284,651.27), ARPA-22001.Contracts.HHAP5.Prevention (52,942.23), ARPA-22001.Contracts.HHAP5.Coordination (\$57,873.10), ARPA-22001.Contracts.HHAP5.Outreach (31,160.84), and authorize the Interim City Manager or Designee to execute the HHAP Round 5 Subrecipient Agreements (4) in a form acceptable by City Attorney.
