A RESOLUTION OF THE LODI CITY COUNCIL AUTHORIZING THE INTERIM CITY MANAGER TO EXECUTE ADDITIONAL CHANGE ORDERS TO THE WHITE SLOUGH WATER POLLUTION CONTROL FACILITY ELECTRICAL BUILDING ASSOCIATED IMPROVEMENTS PROJECT, APPROPRIATE FUNDS, AND AUTHORIZE LODI ELECTRIC UTILITY TO OBTAIN BIDS AND PURCHASE POWER CABLE FROM THE LOWEST RESPONSIVE BIDDER

WHEREAS, the White Slough Water Pollution Control Facility Electrical Building Project requires additional work due to unforeseen field conditions, existing facility constraints, and system-integration needs; and

WHEREAS, the additional work includes new service wiring, MCC wiring modifications, conduit and control wiring revisions, emergency repair of a failed underground airline, and contingency for final system integration; and

WHEREAS, Lodi Electric Utility (LEU) must also redesign electrical service and purchase power cable necessary to complete the project; and

WHEREAS, staff has reviewed project costs and determined the requested funds are necessary to complete the project and maintain reliable plant operations, and recommends that the City Council authorize the Interim City Manager to execute additional change orders in the amount of \$700,000, appropriate \$1,300,000, and authorize LEU to obtain bids and purchase power cable from the lowest responsive bidder in an amount not-to-exceed \$400,000.

NOW, THEREFORE, BE IT RESOLVED that the Lodi City Council does hereby authorize the Interim City Manager to execute additional change orders in the amount of \$700,000, authorize Lodi Electric Utility to obtain bids and purchase power cable from the lowest responsive bidder in an amount not-to-exceed \$400,000, and appropriate funds:
