Circumstances giving rise to this claim and why you believe the City of Lodi is responsible:

Claim for \$7,468.77 due to City's failure to provide title/ownership documents for a surplus vehicle purchased at auction, rendering the sale void. Despite full payment and repeated follow-ups. The City has not delivered the required REG 227 or title, leaving the vehicle unusable and untransferable.

General description of the indebtedness, obligation, injury, damage, or loss incurred so far as it may be known at the time of the presentation of the claim.

I have incurred a financial loss of \$6,268.77 for a vehicle I cannot use, register, insure, or resell due to the City of Lodi's failure to provide required ownership documents. I am also seeking \$1,200. in compensation for the administrative burden and time spent attempting to resolve this issue, totaling in \$7,468.77 in losses to date.

Basis for computation of claim:

Amount Claimed: \$ 7,468.77

\$6,268.77 represents the full amount paid for a 2014 Dodge Grand Caravan (VIN:2C4RDGBGXER380153) purchased at public auction and rendered unusable due to the City's failure to provide title/ownership documents. An additional \$1,200 is claimed for administrative time, effort, and related expenses incurred in repeated but unsuccessful attempts to resolve the matter.

If amount claimed exceeds \$10,000: If the amount claimed exceeds ten thousand dollars (\$10,000), no dollar amount shall be included in the claim. However, it shall indicate whether the claim would be a limited civil case. A limited civil case is one where the recovery sought, exclusive of attorney fees, interest, and court costs does not exceed \$25,000. An unlimited civil case is one in which the recovery sought is more than \$25,000 (CCP §86.)
